

ELIGIBILITY CRITERIA

i. Ph.D. in Engineering / Technology

For admission to Ph.D. Programs in Engineering/Technology or related disciplines, the candidate must have minimum 55% marks or minimum grade equivalent to 55% marks in M.E/ M.Tech in related/ allied disciplines.

ii. Ph.D. in Management, Pharmacy and Non-Engineering Disciplines

For Ph.D. Programs in Management, Pharmacy and Non- Engineering fields, the candidate must have minimum 55% marks or equivalent Grade in PG Degree in related/ allied disciplines.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates. *as per UGC norms

DURATION

- (i) Ph.D. Programme shall be for a minimum duration of three (3) years, including course work, and a maximum duration of six (6) years from the date of admission to the Ph.D. programme or as finalized by UGC, whichever is less.
- (ii) A maximum of an additional two (2) years can be given through a process of re-registration as per the Statute/Ordinance of the Higher Education Institution concerned; provided, however, that the total period for completion of a Ph.D. programme should not exceed eight years from the date of admission in the Ph.D. programme.

Provided further that Female Ph.D. Scholars and Persons With Disabilities (having more than 40% disability) may be allowed an additional relaxation of two (2) years; however the total period for completion of a Ph.D. programme in such cases should not exceed ten (10) years from the date of admission in Ph.D. programme.

(iii) Female Ph.D. Scholars may be provided Maternity Leave/Child Care Leave for up to 240 days in the entire duration of Ph.D. programme. *as per UGC norms

However, Hon'ble Vice Chancellor of the University may extend the duration as per UGC guidelines.

Ph.D. ADMISSION PROCESS

i. PhD admission is done twice in an academic year, generally in January and June, on the basis of written test followed by interview. The exact dates for the same is notified on the website of the University.

ii. Interested candidates can apply against the advertisements, in the prescribed application forms available from the University and on the website.

iii. The Entrance Test is a qualifying test for admission in PhD programme. The syllabus for the entrance examination is available at the Lingaya's Vidyapeeth website: www.lingayasvidyapeeth. edu.in which is updated from time to time.

iv. Exemption from Entrance test: Candidates who have qualified in UGC/CSIR (JRF) Examination/ SLET/ GATE/ GPAT/ M .Phil etc. may not be required to appear for entrance written test of the University. However, their appearance in the interview shall be mandatory for admission for such category of candidates.

v. Selection: A merit list will be prepared Department wise for admission based on the performance in the Entrance Test & Interview-Presentation. Only a pre- determined number of scholars, depending upon the available faculties, shall be selected for admission in the Ph.D programme.

Ph.D. SELECTION PROCESS

The provisional admission of candidates shall be made, based on entrance test, followed by inter - view / presentation.

Stage 1: Entrance Test

a) The Entrance Test will be conducted by the University.

b) Candidates are required to bring with them an original identity proof having photograph, such as Aadhar Card, Voter ID Card, Driving License, Passport and ID Card issued by Govt. Agencies.

c) Entrance Test (70 Marks) of 90 minutes duration, will be held in the University Campus.

d) The syllabus of the Entrance Test is as per the 'University Grants Commission (UGC (Minimum Standards and Procedures for award of Ph.D Degree) Regulations, 2022 comprising 50% on Research methodology and 50% on Specific subject.

e) The syllabus for the entrance test consists of 50% of Research Methodology as Part-A and 50%Subject Specific as Part-B. There will be 35 Multiple Choice Questions (MCQs) from Part-A and 35 Multiple Choice Questions (MCQs) from Part-B in the Entrance Test with one mark each with no negative marking.

f) Those who secure at least 50% marks in the Entrance Test (45% marks in case of SC/ST/OBC

(Non-Creamy layers) / Differently abled persons, EWS and other categories of candidates as per the decision of UGC from time to time will be shortlisted for the interview in order of merit subject to the available seats.)

Stage 2: Interview/ Presentation

a) Short-listed Candidates in the Entrance Test will be called for interview/presentation of research area before the Discipline specific Departmental Research Committee.

b) The Interview (30 Marks) will be conducted for shortlisted candidates.

c) Offer letters for admission will be sent to the Selected Candidates only.

The merit list for admission shall be prepared by Departmental Research Committee according to the following criteria UGC Notification on (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022 dated 7th November, 2022.

a) 70% marks from the entrance/70% marks to the candidates exempted from entrance.

b) 30% marks based on performance in the interview/viva-voce to be conducted by the respective Department.

Ph.D. COURSE WORK AND CREDITS

Ph.D. Course Work: All scholars admitted to the Ph.D. programme shall be required to complete the course work of stipulated credits prescribed by the Department during the initial one or two semesters (6 months or 1 year) after joining the University with the required minimum CGPA of 5.8. However, the period may be extended for one year with the approval of Vice Chancellor.

LV Full Time Ph.D. Fellowship 2023:

Lingaya's Vidyapeeth offers the full time Ph.D. fellowship to the meritorious candidates at the following conditions:

- (i) All full-time scholars admitted into Ph.D. programme will get a junior fellowship of minimum INR 30,000 per month for First year, INR 35,000 per month for Second year and INR 37,000 per month for Third year. Further, the fellowship amount shall be reviewed and considered by a committee.
- (ii) Post deposit of registration fee, total fee will be deducted in equal monthly instalments from the fellowship of the candidate.
- (iii) The fellowship amount will be enhanced as per the experience and knowledge of the scholars. There is no bar for maximum fellowship amount for deserving candidates.
- (iv) Upon completion of Ph.D., scholar will get back the paid fees in monthly instalments as per LV policy for its employees.
- (v) Regular scholars opting Ph.D. will be given the experience of teaching by offering him / her work load in the respective departments.
- (vi) The scholars will be designated as Junior Fellow / Teaching Assistant / Assistant Professor as per the number of years of experience and knowledge.

LV Policy for its Employees:

- (vii) Upon completion of Ph.D. by the employee / employees, fee deducted from the salary of the employee / employees on monthly basis will be reimbursed in the same monthly ratio as deducted.
- (viii) After completion of Ph.D., scholar has to work for a minimum time duration of One year. In case, he / she cannot continue, he / she has to refund 33 % of fellowship amount before getting relieved.

Note:

- (i) Merely being eligible for the interview and facing it does not entitle the candidate for Ph.D. admission. Based on the performance in the interview a candidate may be reported as 'Not Found Suitable' and hence may not get selected.
- (ii) All the admitted candidates will be governed by the Academic Regulation and/ or Ordinance as laid down by the University and amended from time to time.
- (iii) In the case of any inconsistencies in the rules or any clarification thereof, the matter shall be referred to the competent authority for interpretation whose decision shall be final.
- (iv) Detailed Ph. D. Guidelines is available at University website.
- (v) Candidate without depositing the application fee shall not be considered for entrance test.
