## Amendment in Academic Regulations under Clause GR-1-4-2

In view of administrative and academic considerations, the following amendments are made under Clause GR-1-4-2, effective immediately, and shall remain in force until further orders:

### **a. Suspension of the n-4 Rule**

The *n-4 rule* is kept on hold for all programmes across the University until further notice except pharmacy courses.

### **b. Exception for Pharmacy Programmes**

The *n-4 rule* will remain compulsory and continuously applicable for Pharmacy programmes as per Pharmacy Council of India (PCI) regulations.

### **c. Special Provision for Pharmacy Students - Mercy Plea**

An amendment is suggested for Pharmacy programmes, wherein a mercy plea may be considered, subject to the approval of the Vice Chancellor, and the fulfilment of the following conditions:

#### **1. Eligibility for Mercy Plea**

The student must have not more than six (6) reappear subjects under the *n-4 criteria* excluding carryforwarded cases.

#### **2. Extra Class Fee Payment**

The student must pay a fee of Rs. 2,000/- per subject for attending extra/special classes provided by the University, which is a prerequisite for provisional/Temporary registration in the upcoming semester.

#### **3. Affidavit Requirement**

The student must submit an affidavit/undertaking on Rs. 100/- stamp paper before commencement of semester classes, declaring their commitment to:

- Attend all extra/special classes not less than 75%
- Appear for the special mercy test scheduled before the end-semester examinations.

#### **4. Provisional Registration Terms**

- The student may be provisionally registered and allowed to attend regular classes after payment of full semester fee.
- However, the student cannot appear for final semester exams unless the *n-4 criteria* are fully met.

#### **5. No Litigation clause**

The student shall cease the right to further exemptions or to appeal in any court of law regarding this policy implemented to benefit maximum students.

#### **6. Conditional Internal Assessment**

Any midterm or practical marks awarded during provisional registration will be considered valid only if the *n-4 rule* is cleared. Otherwise, these marks will be treated as null and void.

#### **7. Disciplinary Criteria**

The student must not have any ongoing disciplinary or detention cases.

#### **8. Examination Fee**

The exam fee per subject under this mercy provision shall be Rs. 1,200/-. Not Rs. 2,500/- which is for a special exam as per policy.

11. I will pay Rs.1200/- exam fee per subject under the mercy provision.
