Lingaya's Society (formerly Lingaya's Jankalyan Shikshan Sanstha) was established in the memory of freedom fighter, Late Shri Lingaya Gadde, who devoted his life to combating conventionalism, illiteracy, and poverty. An agriculturist, who participated in the 1923 Civil Disobedience and Quit India Movement, faced imprisonment multiple times, wrote on socio-communist issues, served as editor of *Navyuga*, organized the communist party, and founded Adarsha Grandha Mandali in Elamarru, Andhra Pradesh. Inspired by his ideals, the Lingaya's Society is committed to social development based on devotion, sacrifice, and progressive thought.

Prof. G.V.K. Sinha was a distinguished educationist and visionary leader in technical and management education. Beginning his career as a lecturer, he rose to serve as the Head of Department, Assistant Director, Principal at reputed institutions in New Delhi, and later as a full-time consultant with AICTE. Guided by strong humanitarian values, he went on to found and lead the Lingaya's Group as its Chairman, in memory of his father, freedom fighter Shri Lingaya Gadde.

Through his expertise in curriculum development, human resource management, and training and placement, he transformed Lingaya's Institute of Management and Technology into a leading institution in Delhi NCR. In recognition of its excellence, the institute was upgraded to Lingaya's Vidyapeeth under Section 3 of the UGC Act, 1956. Though Prof. Sinha passed away on 6<sup>th</sup> June 2011, his vision and legacy continues to inspire generations.

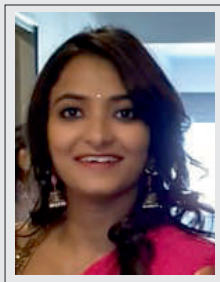

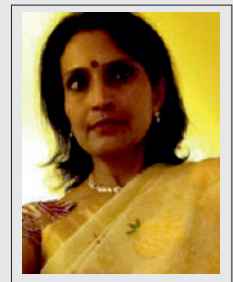

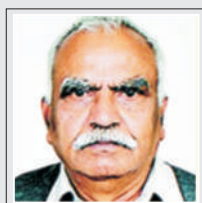

# SCHOLARSHIP & INCENTIVE SCHEMES

1. **Academic Scholarship:** Students with a minimum GPA of 8.5, at least 95% attendance, and no disciplinary record are eligible for a 10% tuition fee concession.
2. **Fee Deposit Incentive:** A 2.5% fee concession is offered to students who deposit the full-year fee within 7 days of the odd-semester fee notice.
3. **Extracurricular Incentive:** Students excelling in sports, cultural activities, or community service receive recognition and awards.
4. **Research & Innovation Incentive:** Students involved in research, innovation or entrepreneurship are supported through financial assistance, mentorship and opportunities for publication, presentation or startups.
5. **Leadership & Entrepreneurship Incentive:** Students demonstrating strong leadership or entrepreneurial skills receive mentorship, networking, technical support, funding and infrastructure to launch ventures.
6. **Policy Review:** Incentive schemes may be revised periodically based on feedback and their impact on student performance and engagement.



Pre-requisite for continuation of Scholarship /Tuition Fee Waiver

- The student must have no indiscipline cases.
- Minimum 95% attendance is mandatory.
- The student must be eligible to appear in the end-semester examination.
- Only one scholarship or tuition fee waiver is permitted during the program tenure.
- The prescribed fee must be paid within the stipulated deadline.
- The student must not be involved in illegal activities like groupism or anti-university activity.
- Scholarships are not granted to students with academic backlogs.
- The student must pay the full first-year fee, with any eligible scholarship disbursed separately upon meeting admission conditions.

**Failure to meet any of the above conditions will result in immediate discontinuation of the scholarship with no scope for continuation requests.**

# Ph.D ADMISSION PROCESS & RELATED INFORMATION

All the candidates seeking admission to various Programs of the Vidyapeeth must apply Online /Offline as per the prescribed format available on the Website or with the Vidyapeeth. Admissions will be based on an Entrance Test and Interview process strictly as per merit.

## Admission to Ph.D. Program

### Eligibility

#### 1 Ph.D in Engineering Technology related disciplines:

For admission to Ph.D. Programs in Engineering/ Technology or related disciplines, the candidate must have minimum 55% marks or minimum grade point equivalent to 55% Marks in M.E/M.Tech in the concerned subject or related/ allied disciplines.

#### 2 Ph.D. in Basic Sciences (Physics, Chemistry, Mathematics):

Candidate must have minimum 55% marks or minimum grade point equivalent to 55% marks in M.Sc./ M.Tech in the concerned subject or related/ allied disciplines. B.Sc. (4 Year) research/ NET/ GATE qualified.

#### 3 Ph.D. in Management, Pharmacy, and NonEngineering Disciplines:

For Ph.D. Programs in Management, Pharmacy, and Non-Engineering fields, the candidates must have minimum of 55% marks or equivalent Grade in PG Degree in the concerned subject or related/allied disciplines.

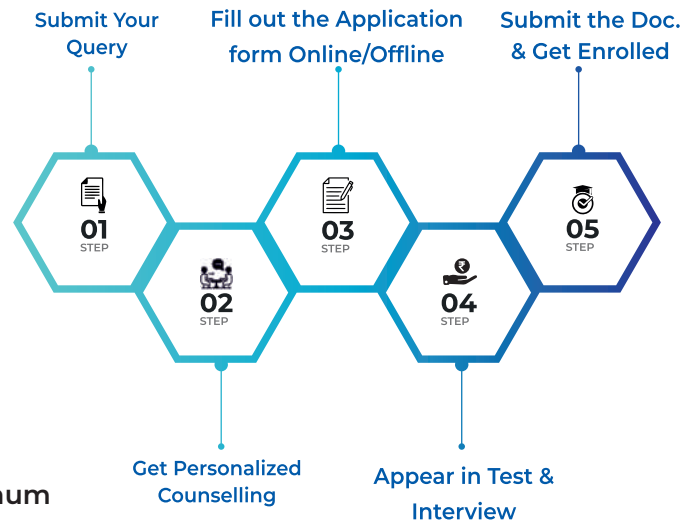
## Admission Process

### Admission for the Ph.D. Entrance Exam

- 1 The interested candidates shall apply through a formal application form, available on the Website of the Vidyapeeth or from the Academics Section of the Vidyapeeth for the entrance test in January & June.
- 2 UGC NET/ JRF, SLET, GATE, CSIR and equivalent exams qualified candidates are exempted from entrance test.
- 3 A merit list will be prepared department-wise for admission.
- 4 Admission may be made twice in a year: Winter Session (Dec-Jan) and Summer Session (June- July). The exact dates for the same shall be notified on the Website of the Vidyapeeth.
- 5 Only a predetermined number of students, depending upon vacancies shall be selected for admission to the Ph.D program.

6 Candidates will be admitted in only those areas of specialization for which resources and facilities are available in the Vidyapeeth.

7 Full-time Ph.D. Scholars shall be given (Rs. 30,000 - 40,000/-) fellowship as per the UGC norms.



# ADMISSION PROCEDURE FOR INTERNATIONAL STUDENTS

## Application Submission Process

Applicants must submit the application form to the International Admissions Office along with the prescribed fee and required documents by mail or post.

## Document Verification

Documents are forwarded by the student or the International Student Global Relations (ISGR) Cell to the Association of Indian Universities or other relevant councils to obtain an equivalence certificate confirming eligibility. Foreign students are exempt from entrance examinations unless required by a statutory body, subject to meeting eligibility criteria.



## Visa Requirements

- 1 Entrance examinations are not required for foreign students unless mandated by a statutory body.
- 2 After eligibility verification, the ISGR Cell issues a provisional admission letter and advises the student to obtain a student visa.
- 3 On submission of the visa and required certificates, the student is instructed to deposit the prescribed fee and medical certificate.
- 4 A valid student visa is mandatory for all Foreign National and NRI students for full-time programmes; no other visa endorsement is accepted.

## Fee Payment Guidelines

International students must pay fees in USD.

# CODE OF CONDUCT AND ETHICS FOR STUDENTS

- Wear decent clothes, respecting your modesty as well as that of others.
- Respect and show regard for teachers, staff and fellow students.
- Inculcate civic sense and sensitivity for environment protection.
- Do not resort to collection of funds for any use without written permission of the head of the institution.
- Exhibit exemplary behaviour, discipline, diligence and good conduct and be a role model to other students.
- Smoking/ Drinking/ Use of Drugs is strictly prohibited on the Campus.
- Do not indulge in offenses of cognizable nature. Do not practice casteism and communalism.
- Do not indulge in any conduct unbecoming of a professional student of the University.
- Do not outrage the status, dignity and honour of any person.
- Do not get involved in physical assault or threat and use of physical force against anyone.
- Do not expose fellow students to ridicule and contempt that may affect their self-esteem.
- Do not form any kind of Student Union, etc.
- Do not take an active or passive part in any form of strikes/protests.
- Observe all safety precautions while working.
- Do not disfigure/damage the Vidyapeeth property, building, furniture, machinery, library books, fixtures, fittings, etc. (The damage/loss caused shall have to be made good by the students) and disciplinary action shall be taken.
- Abide by the rules and regulations of the Group stipulated from time to time.
- Use of mobile/video camera phones is strictly prohibited inside the exam hall, classroom, laboratories, corridors and other working places. The Vidyapeeth authority has the right to confiscate the mobile phone in case of any such violation.

- Always carry your I-Card and produce it on demand. At the beginning of every session, the Identity Card is to be renewed. If lost, a duplicate card will be issued.
- Attend all lectures, tutorials and practical classes of the course punctually. Attendance will be counted course-wise. In case of short-attendance, you will not be permitted to appear in the examination.
- Do not litter the campus; use the dustbins.
- Communicate the change in contact details of yours/your parents/ your guardian promptly to the department.
- Any student indulging in any of the forbidden practices, including ragging, may attract any/ combination of the following disciplinary measures:-
  - a) Cancellation of Scholarships/ Freeships (in part or in whole, temporarily or permanently) by the prescribed rules.
  - b) Fine Suspension /Expulsion/ Rustication.
  - c) Abstain from any misuse of Internet / Social Media networks jeopardising discipline and decency. Students are strictly advised not to engage in ragging.
- Any student involved in ragging on campus, in buses, or hostels will face disciplinary action as per the rulings of the Hon'ble Supreme Court of India and guidelines from UGC. Such students may even be expelled from the university.
